

## FEDERAL SUPPLY SCHEDULE (FSS) ORDER ONE PAGE CHECKLIST How to issue an FSS order for Professional Services

- 1. Determine the <u>Special Item Number (SIN)</u> representing the principle purpose of your requirement.
- 2. Issue order Solicitation under the determined SIN. <u>GSA's RFQ tool eBuy</u> is designed for this purpose. Orders may be set-aside for small business <u>FAR 8.405-5</u>.
  - Request for Quotation (RFQ) at or below micro-purchase threshold <u>FAR</u> <u>8.405-2(c)(1)</u>
    - Issue order directly to any FSS contractor listed in the determined SIN that can meet the requirement.
  - RFQ exceeding micro-purchase threshold up to the simplified acquisition threshold <u>FAR 8.405-2(c)(2)</u>
    - Include SOW, evaluation criteria, and type of order (*i.e.,* firm fixed price, labor-hour\*\*, time-and-materials\*\* or hybrid). \*\*Note: T&M/LH requires a Determination and Findings (D&F) as detailed in <u>FAR 8.404(h)</u>. See <u>Order Level Materials</u> for more information.
    - RFQ must be provided to at least 3 FSS contractors that offer services to meet the requirement.
  - **RFQ exceeding the simplified acquistioon threshold** <u>FAR 8.405-2(c)(3)</u> Include Statement of Work (SOW), evaluation criteria, and type of order (*i.e.,* firm fixed price, labor-hour\*\*, time-and-materials\*\* or hybrid). \*\*Note: T&M/LH requires a Determination and Findings (D&F) as detailed in <u>FAR 8.404(h)</u>. See <u>Order Level Materials</u> for more information.
    - Must seek a price reduction <u>FAR 8.405-4</u>.
    - Post the RFQ on <u>eBuy</u> <u>OR;</u>
    - Provide enough FSS contractors the RFQ to ensure at least three quotes are received.
- 3. Evaluate quotes and make award in accordance with your RFQ evaluation criteria <u>FAR</u> <u>8.405-2(d)</u>.
  - Document award decision FAR 8.405-2(f).
  - Must consider the level of effort and mix of labor proposed to determine that the total price is reasonable.
  - Award order to successful offeror (must reference FSS contract number)..
  - Provide notice to unsuccessful offerors.
  - Provide a "brief explanation" to unsuccesful offerors who request it.
  - When reporting in FPDS ensure order references the FSS Contract number.
- 4. Federal Business Opportunities (FBO) notice of award not required except as detailed in FAR 5.301(a)(2).
